Each year, Universidad Autónoma de Madrid launches an Aid Scheme for students enrolled at UAM who, in possession of refugee or asylum-seeker status, meet the required conditions and need support to commence or continue their studies.

3.1.1. Current Call for Applications

Title:

RESOLUTION BY THE UNIVERSIDAD AUTÓNOMA DE MADRID VICE-RECTORATE for social commitment and sustainability calling for applications to the Aid Scheme for students holding refugee and/or asylum-seeker status.

AIM:

To offer an Aid Scheme for students enrolled at UAM who, in possession of refugee or asylum-seeker status, need support to commence or continue their studies and meet the conditions described in article 3 herein.

AID MODALITIES:

The aid offered may be provided in the following modalities:

- Public rates and fees for full or partial enrolment in the corresponding course of study at UAM.
- Public rates and fees for enrolment in Spanish language studies at UAM.
- Fees for issuing diploma certificates.
- Monthly economic support:
 - Full support (up to 1000 euros per month)
 - Partial aid (up to 400 euros)
 - Monthly support exclusively for transportation costs (as appropriate in the area)
 - Monthly support for meals at the campus dining facility
 - Complementary support for reprography requirements (up to a maximum of 10 euros per month).
- Psychological support in collaboration with the Centre of Applied Psychology [*Centro de Psicología Aplicada - CPA*].
- Socio-educational support provided by UAM students on a volunteering basis.

TARGET POPULATION:

This call for applications is addressed to foreign non-EU students, over 18 years of age, enrolled in undergraduate or graduate studies at UAM for the current academic year who meet the following conditions:

- a) Being in possession of refugee status in Spain, as per Law 12/2009, of 30 October, regulating the Right of Asylum and Subsidiary Protection.
- b) Having applied for refugee status in Spain and holding a 'red card' or proof of application for international protection.

- c) Being enrolled in undergraduate or graduate studies at UAM for the current academic year. Minimum 60 credits for full enrolment, and 30 credits for partial enrolment.
- d) Undergraduate students may apply for this aid scheme during a maximum period of five consecutive years, except in the case of programmes structured over a longer period of time. In the case of Master's Degree programmes, the aid scheme may be applied for during a maximum of two consecutive years and, in the case of PhD programmes, up to four years.

Students wishing to participate in the Aid Scheme are invited to submit their application to the Solidarity and Cooperation Bureau, **within one month of the publication of this call** at the UAM General Registry or by any of the means indicated in Law 39/2015, of 1 October.
